Qualification.

- (a) Essential. Matric / equivalent from recognized Board.
- (b) <u>Desirable</u>. Conversant with the duties of respective trade with one-year experience in the trade.
- 4. <u>Age Limit.</u> 18 to 25 years as on the prescribed LAST DATE for receipt of application. However, age relaxation upto 45 years will be applicable as per Govt instructions as under:
 - (a) 03 years for the candidates belonging to **OBC** category.
 - (b) 05 years for the candidates of SC/ST category.
 - (c) 10 years for the candidates belonging to **Persons with Disabilities (PwD)** category (Additional 05 years in case of PwD candidate belonging to SC, ST and 03 years for OBC).
 - (d) **Ex-Servicemen** who have rendered not less than 06 months of continuous service after attestation in the Armed forces shall be allowed to deduct the full period of such service from their actual age and if the resultant age does not exceed the prescribed maximum age by more than three years, they shall he deemed to be within age limits.
 - (e) **SC/ST/OBC** candidates applying against **Unreserved** post are not entitled to any relaxation in age limit, experience etc.
 - (f) Departmental Employees with three years continuous service: 40 years for UR, 43 years for OBC, 45 years for SC/ST.

5. Terms of Engagement.

- (a) New entrants to Government service, entering on or after 01 Jan 2004 are governed by National Pension System.
- (b) The appointment will be on probation for a period of two years followed by permanent absorption subject to found suitable during the probation period.
- (c) As per the Govt orders retention of Govt servant beyond 55 yrs of age/30 yrs of qualifying service (whichever is applicable) will be carried out by screening committee, if found suitable. Govt servants whose integrity is doubtful will not be retained. If found suitable for retention, the Government service will retire from service on attaining age of 60 years.

- (d) The candidate will disqualify for the Govt Service in case he or she has entered into or contracted a marriage with a person having a spouse living OR who having a spouse living, has entered into or contracted another marriage.
- 6. <u>Last date for Receipt of Applications</u>. **30 days** from the date of publication of this advertisement.
- 7. <u>Scheme of Examination</u>. A written test of 100 marks will be held which will have questions of the level of Class 10th. Questions included will be of General Intelligence & Reasoning, General Awareness, English and Mathematics (Numerical Aptitude). The format of question paper wil be objective ie Multiple Choice Questions (MCQ) only. Candidates appearing for written test would also be subjected to practical skill/trade test whichever applicable. The skill test will be of qualifying in nature and carries no separate marks. Selection will be made strictly on the basis of merit of written test subject to candidate qualifying in the skill test.

Note:

- (a) The question paper will be bilingual i.e. English and Hindi. However, the question of 'English' section will be in English language only. No extra weightage will be given for additional/extra or higher qualification for recruitment.
- (b) If the number of applications received in response to the advertisement are large and it is not convenient or possible to arrange the examination for all the candidates, the selection board reserves the right to restrict the number of candidates to a reasonable limit on the basis of percentage or marks obtained in the prescribed minimum essential qualification i.e Matric or equivalent.
- (c) Shortlisted candidates would be intimated the date, time and venue for conduct of written examination, skill/trade test. Only candidates who receive the call letter are required to appear for the examination along with the call letter received. This department is not responsible for any postal delay that may occur.
- (d) The written test and skill/trade test would be held at **Pune, Maharashtra**. Candidates should come prepared to stay for two-three days for completion of the recruitment process. Candidates have to make their own arrangements for boarding/lodging during the period of stay. No travelling allowance / dearness allowance would be paid to the candidates called for the examination.
