Such candidates in the Main List who fail to produce the required Certificate at the time of interview will not be entitled to the benefit of reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists of Economically Weaker Sections/ Other Backward Classes/ Scheduled Castes/ Scheduled Tribes, their Roll Numbers will be deleted from the Short List without further notice, if they fail to produce the required Certificate.

The date, time and place of the Practical Test will be intimated in due course.
